## PLACEMENT OVERVIEW

Fellowship Position Title: Voting Rights Fellow

**Fellowship Position Summary:** The Fellow will support the Fair Elections Legal Network's (FELN) advocacy, policy, research, and communications efforts. This will include research related to policy briefs on topics such as the use of new technologies to increase voter registration rates. The Fellow will also track developments and manage contacts for Campus Vote Project, a 10-state effort to encourage colleges and universities to implement policies that will reduce barriers to voting for students. In addition, the Fellow will work to create unique opportunities for Bonner schools to participate in the Campus Vote Project.

#### **Specific Position Activities:**

1) research on policy briefs on topics like the use of new technology in efforts to increase voter registration rates;

2) development of op-eds (opinion- editorial) and blog posts for FELN and Campus Vote Project; and3) create unique opportunities between the Bonner Network and Campus Vote Project

## AGENCY DESCRIPTION

**Mission Statement:** The Fair Elections Legal Network (FELN) is a national, nonpartisan advocacy organization based in Washington, D.C. whose overall mission is to remove barriers to registration and voting for traditionally underrepresented constituencies and improve overall election administration through administrative, legal, and legislative reform.

**Organizational Goals:** FELN partners with progressive coalitions of nonpartisan, nonprofit state organizations to provide technical assistance, training, and strategic advice on election administration, voter registration, and "get out the vote" efforts. We work on college campuses to break down barriers to voting that disproportionately affect students. FELN produces policy briefs that advocate creative solutions to contemporary voting rights problems such as home foreclosures and antiquated voter registration systems. The organization's communications team supports these efforts by regularly updating the public on voter suppression legislation. Communications staff write blog posts and op-eds that advocate strategies for increasing access to democratic participation for traditionally underrepresented communities. FELN also has a robust social media program, which will help a Bonner fellow develop skills using emerging communications tools for political activism..

Bonner Fellows will represent some of the most standout students across the Bonner Network, ideally rising juniors and seniors with previous summer internship experience and interested in building their professional network, who demonstrate:

- excellent organization, written and oral communication, and analytical skills;
- ability to work autonomously and in team settings;
- · readiness for a capstone-level project;

AmeriCorps (NO): This position is ineligible for AmeriCorps, because of its focus on political advocacy.
